To be approved as Payment Guarantor:

- *Receive a favorable credit evaluation.*
- *Be 21 years of age or older.*
- *Have a regular source of income.*
- *Be a U.S. citizen with a permanent U.S. address.*
- *May not be the borrower or the spouse of the borrower.*

Important Facts ...

- ✓ *The student is the borrower of the College Access Loan.*
- ✓ *If eligible, you may receive up to \$10,000 in an academic year. **Your school determines your eligibility.***
- ✓ *Repayment of your loan begins six months after you cease to be enrolled at least halftime in school.*
- ✓ *Interest accrues from the date of your check and you are responsible for this interest. You may make interest payments while in school. Please contact our Account Services Office for information.*
- ✓ *The CAL interest rate is 7.5% simple, fixed rate throughout the life of the loan.*
- ✓ *Interest is not capitalized.*
- ✓ *There is a 3.0% origination fee deducted from the loan proceeds at the time of disbursement. Amount of this fee is subject to change.*
