This agreement was executed on _____, 20____ between St. Mary's University, hereinafter known as the "School," for students enrolled in the program specializing in Community/Mental Health/Marriage and Family Therapy Program in the Department of Counseling and Human Services, and _____, hereinafter known as "Facility."

Whereas, the purpose of the Community/Mental Health/Marriage and Family Therapy Counseling program in the School is to develop qualified professionals in the field of Community/Mental Health/Marriage and Family Therapy Counseling to serve the needs of the profession and the community and

Whereas, it is of mutual interest and advantage of the School and the Facility, that the students be given the opportunity to utilize the Facility for educational purposes,

The School and Facility agree as follows:

- (1) Students participating in the Internship shall have completed a minimum of 27 semester hours of formal course work of the approved Master's Degree Program in Counseling/Therapy.
- (2) Students will be in the Facility during the period agreed upon by the student, the Facility and the School. The student will be under the supervision of a faculty member of the School as well as an on-site supervisor.
- (3) The names of students and period of assignment for each student will be furnished the Facility by the School.
- (4) All students will provide their own mandatory liability insurance covering the duration of their internship.
- (5) Students are subject to the rules and regulations established by the Facility.
- (6) Students will be responsible for their own transportation, meals, lodging, and health care needs in the performance of this agreement.
- (7) There will be no exchange of monies between the Facility and the School.
- (8) The School will provide the Facility with written Counseling Internship guidelines for site supervisors.
- (9) The School agrees that members of the Faculty may serve as consultants and on committees of the Facility when requested by the Facility.
- (10) The final decision regarding the selection of those students desiring an intern position will rest with Facility staff responsible for supervision.
- (11) The Facility will provide clinical and administrative supervision.

- (12) The specific areas of students' assignment and students being assigned is from year to year unless terminated by either party upon giving six months advance written notice to the other party.
- (13) The final decision regarding the selection of those students desiring an intern position will rest with Facility staff responsible for supervision.
- (14) The student's responsibilities at the Facility will include:

This contract may be terminated by either the School or the Facility with a 30-day notice. Early termination of a student's period of internship can be done with the mutual agreement of all parties involved: Student, Facility and School.
