Award winners will be announced March 31, 2011. The two winners will receive \$600 and \$1,000 respectively in memory of SARAH K. THOMPSON. Recipients are chosen by a committee based on writing ability and persuasiveness.

In order to qualify for the scholarship, applicants must answer the following questions to the best of their ability: Please use additional pages as necessary (no more than two).

1. Sarah was a vocal fan of the Innsbruck program and encouraged all those around her to attend. An applicant must address their reasons for their interest in the Innsbruck Program and possibly their interests in future international work and/or travel.

How would international legal study and international travel benefit your legal education?

2. Sarah's goal was to help the poor in need of legal services, especially the elderly. With a passion for elder law, Sarah was not interested in the law for financial reasons but rather civic philanthropy. She was also a life-long member of Trinity Lutheran Church in Tyler. Applicant must also demonstrate past work they have done, future civic work they intend to do, and civil services they are involved in currently. Work for your congregation or religious community will be viewed favorably.

How are you working to make a difference?

3. The applicant may address some particular way they reached out to support a friend or family member during a time of difficulty or in an unusual situation. Applicants may also indicate how they have lent their support to fellow law students through involvement in law school activities or tutoring.

How have you reached out to your family and friends?

4. The main purpose of the scholarship memorial is to carry on the memory of Sarah. Another main purpose for the scholarship program is alleviating some of the financial weight on applicants. In this way, Sarah's parents know they have allowed another law student to enjoy Innsbruck the way Sarah did. An applicant can demonstrate a financial need for the scholarship and this will be taken into consideration for awards.
